SPECIAL MEETING

MAY 15, 2020

MINUTES

The meeting was called to order at 9:09 A.M. by Chairman Ed Ryder.

Mr. Pavella made the motion to approve the regular meeting minutes of April 16, 2020. Mrs. Windnagel seconded the motion. All voted: AYE.

Mr. Pavella moved to accept on the April 28, 2020, special meeting minutes the first change on Page 1, 6th paragraph Write-ins – "two (2) legitimate write-in ballots and reject the other five (5). Mrs. Windnagel seconded the motion. All voted: AYE.

On Page 2, 1st paragraph, Mr. Pavella moved to change the language concerning the over votes. Over votes change to "ballots" in the first sentence; delete "to accept the Voter intent" in the second sentence; and to add after Mrs. Carson opposed "because she could not see the vote." Mrs. Windnagel seconded the motion. All voted: AYE.

Mr. Pavella made the motion to approve the special meeting minutes of April 28, 2020, as corrected. Mrs. Windnagel seconded the motion. All voted: AYE.

Mr. Pavella made a motion to move the bills on the Agenda to follow the approval of the April 28, 2020, special meeting minutes. Mrs. Windnagel seconded the motion. All voted: AYE. The vouchers will be delivered to the County Auditor for the noon deadline for submittal.

Mr. Pavella made a motion to approve the bills as presented with the amended amount for Quill of \$233.29. Mrs. Windnagel seconded the motion. All voted: AYE.

Rule on indeterminate post marks for 10 day ballots and 11s forms – ShoMore' DeNiro, Regional Liaison, Secretary of State Office, had the Postal Reader for the digital postmarks on the return envelopes.

Director, Pete Zeigler, reported that on May 14, 2020, there were 26 envelopes with ballots delivered to the Geauga County Board of Elections from the Chagrin Falls, Ohio, Post Office with 25 of the envelopes having a postmark date of April 21, 2020, and one envelope was postmarked April 18, 2020. The envelopes needed to be received no later than May 8, 2020, to the Geauga County Board of Elections and postmarked by April 27, 2020. Serita Montgomery and Mitch Tullie, United States Post Office Liaisons for the region, were at the Geauga County Board of Elections Office today to discuss this issue with the Director. The Post Office is concerned, and they are undertaking an investigation. The envelopes did not arrive timely. The Director and the Board members were disappointed that this happened.

Nora McGinnis, Absent Supervisor, presented the 10-Day Absentee Ballot Report of March 17, 2020 (April 28, 2020) and the Provisional Ballots – March 17, 2020, (April 28, 2020) Report. The Board reviewed the reports, envelopes, and ballots.

Nora stated this is the last of the 10-day ballots from March 17, 2020 through May 8, 2020. The March 17, 2020, Presidential Primary Election suspended date was April 28, 2020. The ten-day cure period is May 8, 2020.

The Board reviewed the three, 17-year old ballots. Tax levies and County Central Committee races were ineligible for votes on the 17-year old ballots.

Mr. Pavella made a motion to accept two, 17-year old ballots that appear to be correct; and the third ballot the County Central Committee Race and the two tax levies to be blanked out as ineligible for a vote. Mrs. Windnagel seconded the motion. All voted: AYE.

There were ballots with smudge marks. They were erasure markings.

Mr. Pavella made a motion to approve the two ballots with the smudge marks obvious erased marks for one election race on each ballot. Mrs. Windnagel seconded the motion. All voted: AYE.

The ten over-voted ballots (4 over vote and 6 voter intent) were reviewed by the Board.

Mr. Pavella made a motion to accept that four of the over votes as clearly over-voted ballots. Mrs. Windnagel seconded the motion. All voted: AYE.

Mr. Pavella made a motion to accept the Board approval of six of the intent of the voter ballots. Mrs. Windnagel seconded the motion. All voted: AYE.

The 26 envelopes with ballots received on May 14, 2020, were discussed by the Board.

Mr. Pavella made a motion to regretfully not accept the 26 ballots received in an untimely fashion after the May 8, 2020, deadline that arrived yesterday, May 14, 2020, according to the O.R.C. and the Secretary of State Directive. Mrs. Windnagel seconded the motion.

Discussion continued on this topic. Director Pete Zeigler stated that he had contacted the Secretary of State's Legal Office about this issue. The law is unchanged and very clear. The ballots cannot be accepted. Chairman Ryder recommended a letter to our Congressman and two U.S. Senators to have them look into the Board of Elections not being able to accept 26 ballots, and the voter did their duty in a timely manner. Mr. Ryder resides in the Chagrin Falls Postal District, and there has been trouble for the past 8-10 years since the Bainbridge Post Office was closed. Congressman Joyce is aware of the problem with the delivery of mail at the Chagrin Falls Post Office. Something needs to be done to fix the Chagrin Falls Post Office. Director Zeigler stated that one can concur in this job that these people's vote counts. The Congressman and Senators need to work on possible solutions. Mrs. Carson thought that a Directive from the Secretary of State before the Post Election to address this issue. In review of the envelopes, the postmarks are clearly within the ten-day cure period, and the voter is being penalized. The Secretary of State, Congressman, Senators, and Aaron Ockerman could look into this further.

At this time the vote was taken on Mr. Pavella's motion to reject the 26 ballots. All voted: AYE.

Nora stated that the staff had reviewed and determined that 1,101 ballots had good postmarks (April 27, and prior). Of the 11 envelopes with no postmark, 2 were valid (and not scanned) and 9 were late.

Mr. Pavella made a motion that nine of the envelopes were postmarked after the April 27, 2020, date and were not valid per the O.R.C. Mrs. Windnagel seconded the motion. All voted: AYE.

ShoMore' DiNiro, SOS Office, explained there was no problem with the Secretary of State Postal Scanner in reading the digital markings on the envelopes. Some of the envelopes do not have scan marks; and some of the envelopes are postmarked after the Election.

All envelopes were checked and reviewed by multiple employees and the Director.

Mr. Pavella made a motion not to accept the late illegible postmarks that were scanned on the Secretary of State postal scanner. Mrs. Windnagel seconded the motion. All voted: AYE.

Mr. Pavella made a motion not to accept the 85 envelopes with late postmarks from April 8 – May 8, 2020. Mrs. Windnagel seconded the motion. All voted: AYE.

There was discussion on the 11-S Supplement Form mailed to voters that needed to correct their I.D. envelope due to missing or wrong I.D., and signatures missing. Budget (2020 – 2021) – Director Zeigler stated the Budget for July, 2020 – July, 2021 has not been submitted with the Primary Election there has been an extension granted by the County to give the Board of Elections time from the deadline of May 5, 2020.

The Secretary of State's Office has a re-imbursement form for cleaning and safety supplies for the March 17, 2020 Presidential Primary that needs to be completed and submitted.

Director Zeigler discussed a line item transfer for Supplies and Materials from Contracts. There have been additional expenses with the 2020 Primary Election being extended. Mr. Pavella made a motion to transfer \$15,000 from 1001-050-00-701Contracts to 1001-050-00-601 Supplies and Materials.

Kristine Rine, Geauga County Assistant County Prosecutor, was present at this time.

Mr. Pavella made a motion to go into Executive Session at 11:46 A.M. for the purpose of discussing Compensation of a Public Official RC 121.22(G)(1). Mrs. Windnagel seconded the motion. A roll call vote was taken. Pavella, AYE; Carson, AYE; Ryder, AYE; and Windnagel, AYE.

Director report

OAEA Conference – Director Zeigler recommended that a minimum number of people attend the Secretary of State Conference in Columbus, Ohio, on August 11, 2020, making it non-mandatory for health reasons (Covid-19). The Director is willing to attend, and Mr. Pavella will not.

The May, 2020, Regular Meeting is cancelled.

Post Election Audit Scheduling - Based on the 21,696 votes that were cast, 5 percent is a total of 1084.8 ballots. Director Ed Ryder pulled the following precincts: Hambden Township D - 245; Thompson Township B - 219; Auburn Township C - 267; and Newbury Township A - 379 for a total of 1,110 ballots to be audited.

Mr. Pavella made a motion to hold a special meeting on June 2, 2020, at twelve noon for interviewing of public employees, approve audit results, and paying bills. Mrs. Windnagel seconded the motion. All voted: AYE.

Certify Official Election Results - Mr. Pavella made a motion to accept the Official Canvass of the March 17, 2020, Primary Election. Mrs. Windnagel seconded the motion. All voted: AYE.

Schedule recount if necessary – Not needed. An Application for a requested recount is needed by May 20, 2020.

The Board of Elections is now using Web Ex for teleconferencing the meetings. Director Zeigler will schedule a session with the County I.T. Department. Web Ex is different from Zoom.

Mr. Pavella made the motion to adjourn the meeting at 12:54 P.M. Mrs. Windnagel seconded the motion. All voted: AYE.
